## Challenges Continued

"We looked at a number of different companies who provided document editing," says Love. "We looked at open source and paid solutions all across the market, but we were really picky because we knew exactly what we were looking for. When I asked the team, one of our senior engineers mentioned that he knew Accusoft and we were already using one of the products."

The team at Canopy researched the tools their customers were using. That research helped lead to a final decision. Around 90% of Canopy's clients use a Microsoft Office (MSO) product, and they are familiar with the user interface and its functionality.

"We wanted something that mimicked the look and feel, but provided higher security for sensitive documents," reports Love. "We decided to use PrizmDoc Editor to autofill the client's information into the tax resolution letter and populate any other relevant case information."

During the evaluation phase, before Canopy signed a contract, their engineers were given development licenses to test the product in their environment as a proof of concept. The team was impressed with the ease of integration.
