ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

ELIGIBILITY: The **SRS Distribution Roof Hub Sweepstakes** (the “Sweepstakes”) is not open to the general public. Sweepstakes is open to legal residents of the United States, including the District of Columbia, who are currently employed by or own a professional roofing contractor business, age 18 or older at the time of entry. Void in Alaska, Hawaii, Puerto Rico, Guam, the U.S. Virgin Islands, outside the U.S., and wherever else prohibited by law. Employees of SRS Distribution Inc. (the “Sponsor”), US Sweepstakes & Fulfillment Company (the “Sweepstakes Administrator”) and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state and local laws and regulations.

Within the Sweepstakes Period, there are two (3) Monthly Entry Periods (each, a “Monthly Entry Period”) and two (2) corresponding Monthly Random Drawings (each, a “Drawing”) as defined in the “Monthly Entry Periods & Drawings Schedule” below. Entries must be received during a Monthly Entry Period to be eligible for that Monthly Entry Period’s drawing and prize. Non-winning entries for a Monthly Entry Period will not roll over to subsequent Monthly Entry Periods. Sponsor’s computer is the official timekeeping device for this Sweepstakes.

HOW TO ENTER: There are two (2) ways to enter.

Method #1: Purchase Entry. During the Sweepstakes Period, visit <https://www.roofhub.pro/> or the Roof Hub app and make a minimum purchase of \$2,000. For every purchase that meets the minimum purchase requirement, the entrant will receive one (1) entry into the Sweepstakes (“Purchase Entry”). Return of eligible products associated with a Purchase Entry will void such Purchase Entry. **Purchase Entries must be made during the Sweepstakes Period.** Entrants are subject to all notices posted online including but not limited to the Sponsor’s Privacy Policy, which can be found at <https://srsdistribution.com/About-Us/PrivacyPolicy.aspx>.

Method #2: Free, Alternate Method of Entry (“AMOE”). To enter without purchase, mail a postcard (the “Mail-In Entry”), including your name, complete address, email address and phone number to the following address to receive one (1) entry into the Sweepstakes: **SRS Distribution Roof Hub Sweepstakes, PO Box 728, Social Circle, GA 30025-0958. Each Mail-In Entry must be mailed separately and must be postmarked in accordance with the Monthly Entry Periods & Drawings Schedule.** Photocopied, illegible, or mechanically reproduced entries are not eligible. All entries become the property of the Sponsor and will not be returned or acknowledged. Sponsor is not responsible for lost, late, damaged, misdirected or postage-due mailed entries.

All methods of entry have an equal chance of winning. All entries become the property of the Sponsor and will not be acknowledged or returned.

Limit: Regardless of the method of entry, there is a limit of one (1) entry per customer per day. All methods of entry have an equal chance of winning.

PRIZES/APPROXIMATE RETAIL VALUE (“ARV”)/ODDS:

Monthly Grand Prize: There are two (2) Grand Prizes available to be won. One (1) winner per Monthly Period will receive a Ford F150 XL package.

The ARV of Monthly Grand Prize: \$30,000 each. The ARV of all Monthly Grand Prizes is: \$60,000. ARV is as of date of drafting these Official Rules. The difference between the ARV and actual value of the Monthly Grand Prize will not be awarded.

Sponsor is not responsible for delays in delivery of the Ford F-150 (the "Vehicle"). Winner must take delivery of Vehicle from the automobile dealership designated by the Sponsor. The ARV of Monthly Third Prize: \$200 each. Total ARV of all Monthly Third Prizes is \$4,000.

The total ARV of all prizes available to be won: \$88,000.

There is a limit of one (1) Monthly Prize per person. Odds of winning a Monthly Prize will depend upon the total number of eligible entries received per Monthly Entry Period. Odds of winning a Monthly Prize will depend upon the total number of eligible entries received during the Monthly Sweepstakes Period.

All travel related expenses, including but not limited to, ground transportation to and from home, taxes, gratuities, incidentals, upgrades, insurance, service charges, airport surcharges, departure taxes, hotel, resort or property fees, luggage fees, food & beverage and personal expenses are the sole responsibility of prize winner and/or his/her travel companion(s). Any person that participates in the trip that is not deemed to be a travel companion must pay his/her own expenses. Winner and travel companion must travel on same itinerary. Winner and travel companion must have valid photo ID and any other required documentation prior to departure. Prize must be used on dates specified or prize will be forfeited.
