



Here at BOX, our goal is to help you make as much money as possible. We provide two different commissions options to make sure you get paid your way. Here are the most common questions we get asked about our commissions and payments.

What is the difference between Residual and Upfront payments?

Monthly Residual Commission

Deals must have a start date within 12 months. Residual payments are made on the commission run following signature.

For example, If the contract has a contract submit date of February 2019, payment will be received on the March 2019 commission run.

Annual Upfront Commission

Remaining payments will be made annually on the anniversary of the start date.

Affiliate Partners have a forward start agreement. If the start and booked date are within the forward start window, then payment will be received on the upcoming commission run. If the start date is outside of the forward start window, then payment will be on the commission statement the month following the start date.

For example, if the contract has a forward start of December 2020, commissions will be on the January 2021 statement, paid out by the 8th of February.

What is the difference between ACH and Wire

ACH transfers are typically completed in 1 to 2 business days after the payment is scheduled.

Wire transfers are typically completed the same day payment is scheduled. Depending on the bank, this may require a small fee to retrieve payment.

When can I expect to receive my commission payment?

The 8th of the following month. Commission statements are sent 1-2 days before payment is scheduled.

For example, payment for the March 2021 statement will be received by April 8th, 2021.




