ACTIVE INGREDIENT	DESCRIPTION
<b>L-methylfolate Calcium</b> [active folate (pure crystalline)]	+ Blood flow and nerve repair - Homocysteine levels
<b>Methylcobalamin</b> [active Vitamin B <sub>12</sub> ]	+ Peripheral nerve repair - Homocysteine levels
<b>Pyridoxal 5'-Phosphate</b> [active Vitamin B <sub>6</sub> ]	- Harmful substances that damage nerves - Homocysteine levels
<b>Alpha Lipoic Acid</b> [antioxidant]	+ Blood flow to the peripheral nerves - Inflammation
<b>Cholecalciferol</b> [active Vitamin D <sub>3</sub> ]	+ Factors involved with nerve health

## FREQUENTLY ASKED QUESTIONS

### What are EB-N3<sup>DR</sup>/EB-N5<sup>DR</sup>/EB-N6<sup>DR</sup>?<sup>1</sup>

These products are classified as medical foods, a unique category regulated by the FDA. Medical foods address the metabolic deficiencies associated with diseases to help manage chronic conditions, including blood vessel and nerve damage such as peripheral neuropathy. Medical foods are intended for use under medical supervision.

### What should I expect?<sup>1</sup>

Medical Foods are different from pain medications. While pain medications can help mask painful symptoms, they have a variety of side effects and do not address what's causing the pain.

The active ingredients work together to naturally restore blood flow and help to repair damaged nerves. Because these ingredients work to address the root cause of your symptoms, it may take up to 6 months before you notice a difference.

Once your metabolic needs are met, you may notice a difference in one or more of the following symptoms: Numbness • Burning Pain • Shooting Pain • Tingling • Poor Quality Sleep

### How do I know if it is working?

Up to 50% of people have a compromised ability to complete this activation due to a genetic variant in the enzyme responsible for folate metabolism called MTHFR c677t. *Our products feature Biofolate®, a pure crystalline activated form of folate (L-methylfolate Ca) which is unaffected by the MTHFR c677t variant.*

### What are the side effects?

The active pharmaceutical ingredients in our medical foods are well tolerated and allergen, gluten and dye free. The most common complaints include mild indigestion, upset stomach and headache. If you experience any of these conditions, try taking the capsules with food. If the problem persists, consult your provider.
