LIMRA Anti-Money Laundering Course Base Training & Recertification

The USA PATRIOT Act requires insurance companies to develop and implement Anti-Money Laundering (AML) programs that are reasonably designed to prevent companies from being used to facilitate money laundering or finance terrorist activities.

Fidelity & Guaranty Life has partnered with LIMRA International and is offering AML <u>base and recertification</u> training through LIMRA's AML Training Module. LIMRA's <u>"Fraud in Money Laundering – Anti-Money Laundering for Insurance Review"</u> online course is now available. This year's course has two versions, a flash-version and the regular non-flash version. An individual may complete either one. The content is the same. Once one is completed, the other may not be accessed.

To access the Training Module, please follow these steps:

Newly Contracted Agents Accessing the LIMRA AML Base Course

Log in to the course at the following web address: https://aml.limra.com
The first screen you see when you enter the AML training site will be the login site.

The first screen you see when you enter the AML training site will be the login screen. The first time you log in to the training site, you must enter your user name and password as follows:

- Username Your username is the first four letters of your last name (lowercase) combined with the last six digits of your Social Security number.
- Password Your pre-assigned password is your complete last name (lowercase).
- When you enter your username and password as explained above, you will be prompted to create a new
 password. The new password must be different from the pre-assigned password in order to gain access to
 the training site and proceed with the course.

Thereafter, you may use the **new** password each time you log in to the AML training site.

Agents who have previously completed the AML base course through LIMRA can now access the LIMRA's AML recertification Training Module following these steps:

Previously Contracted Agents Accessing the LIMRA AML Recertification Course

- Username: Your username is your previously assigned user name. The first four letters of your last name combined with the last six digits or your social security number.
- Password -Your password is your previously selfassigned password, if you cannot remember the password you previously created; click on the "Forgot Your Password" link on the page and answer the security question to reset your password.
- Please note that you will not receive a paper certificate of your completion of the course. Instead, the
 Home Page will indicate your completion status for the course. You do not have to notify our office
 when you complete the AML Training Courses. LIMRA will provide Fidelity & Guaranty Life with a
 periodic status report of producers whose AML training is either successfully completed or still pending.
