Treasury Posts New ERAP Resources

Last Friday, the U.S. Department of Treasury ([Treasury](#)) posted the following resources to the Emergency Rental Assistance Program ([ERAP](#)) website:

- The [November ERA report showing](#) that November sets new record for emergency rental assistance disbursed—\$2.9 billion to aid 665,000 households—as eviction filings remain below pre-pandemic levels nationally.

HUD Announces Assistance for Washington Disaster Survivors

In a [press release](#) Friday, the Department of Housing and Urban Development ([HUD](#)) announced the implementation of federal disaster assistance to supplement state, tribal, and local recovery efforts in the areas affected by flooding and mudslides in the State of Washington from November 13 to November 15, 2021.

A presidential [major disaster declaration](#) issued on January 5, 2022, allows HUD to offer assistance to affected individuals living in impacted counties and tribes. Effective immediately, the Department will:

- Grant a [90-day moratorium](#) on foreclosures of FHA-insured homes
- Make mortgage insurance available under [HUD's Section 203\(h\)](#) program
- Make insurance available for both mortgages and home rehabilitation under [HUD's Section 203\(k\) program](#)
- Make [information on housing providers](#) and HUD programs available
- Provide flexibility to Community Planning and Development Grantees, which can apply for needed administrative flexibility in response to natural disasters. For more information on applying for a waiver or suspension of requirements, [contact](#) your local CPD program office.
- Provide flexibility to PHAs, which can apply for needed administrative flexibility through disaster waivers. Click [here](#) for the latest *Federal Register* disaster relief notice. The Department also released Notice [PIH 2021-34](#), which advises the public of HUD's expedited process for waivers and flexibilities from HUD regulatory and administrative requirements for various public housing and voucher programs.
- Ensure [HUD-approved housing counseling agencies](#) are ready to assist
- Assist with housing discrimination

Federal funding, provided by FEMA, is also available on a cost-sharing basis for hazard mitigation measures statewide. Click [here](#) for more information about disaster resources.
