Friday on the Public Housing Financial Management Division (PH-FMD) [email list](#), HUD's Office of Public and Indian Housing (PIH) announced that it has scheduled another lab session on the [Operating Fund \(OpFund\) Web Portal](#), which will take place today, [January 11, 2021](#), from 2:30 p.m. to 3:30 p.m. Eastern time.

As you know, the lab sessions are meant to guide WASS security coordinators in assigning appropriate user roles for the portal, describe the appropriate user roles for the users' needs, and to respond to questions. WASS security coordinators, PHA staff, and the PHA's third-party staff are invited to attend. In submitting questions, attendees are asked to provide their user ID, PHA code, direct phone number, and a short description of their issue.
