### HUD Posts HHS/CDC COVID-19 FAQs and Supplemental PIH FAQs

This week on the [Public and Indian Housing COVID-19 Resources](#) webpage, the Department of Housing and Urban Development ([HUD](#)) posted a new set of frequently asked questions ([FAQs](#)) from the Department of Health and Human Services ([HHS](#)) and the Centers for Disease Control and Prevention ([CDC](#)) regarding the [order](#) under Section 361 of the Public Health Service Act to temporarily halt residential evictions to prevent the further spread of COVID-19. As you recall, the CDC eviction moratorium was published September 4, 2020.

The HHS/CDC FAQs, dated October 9, 2020, address the following topics, among others:

- What the order does, what *eviction* means, and who “covered persons” are
- How someone uses this protection
- The CDC-provided declaration form
- Whether the order applies for evictions that have already occurred or are in process
- Where the order applies
- The reasons for evictions that the order does not prevent
- Residential properties covered by the order

HUD has also posted a [supplemental set of FAQs](#) regarding the CDC order as it relates to HUD's Office of Public and Indian Housing ([PIH](#)) programs. The supplemental PIH FAQs address:

- That the order applies to all PIH programs
- Whether PHAs must notify residents of the order
- Whether covered persons may still be evicted for other reasons than nonpayment of rent
- Whether rents are still owed
- How HUD-assisted residents may use the protection
- The CDC declaration form as it relates to PIH programs
- Whether PHAs are responsible for verifying “truthfulness”
- Whether the order applies to evictions that occurred before the effective date but have yet to be completed
