PIH Reminds PHAs They Are Not Required to Resubmit Their SF-424

In an email to executive directors yesterday via HUD's Financial Management Division (FMD) [mailing list](#), HUD's Office of Public and Indian Housing (PIH) reminded that PHAs are not required to resubmit their SF-424 (application for federal assistance) using the operating fund (OpFund) grant eligibility calculated from their CY 2022 HUD-52723 and HUD-52722. As the email states, HUD prepopulates the SF-424 estimated funding with the PHA's previous year OpFund eligibility. Unless directed by their HUD field office, forms submitted with the HUD prepopulated funding amount are acceptable and do not require update. PHAs that created an SF-424 resubmission through the OpFund web portal may delete their form. If you have additional questions, please contact your local HUD field office.
