HUD Kicks Off Fair Housing Month

In press release issued yesterday, the Department of Housing and Urban Development (<u>HUD</u>) kicked off Fair Housing Month 2021. Each April, HUD, local communities, and fair housing advocates and organizations celebrate Fair Housing Month by hosting various activities highlighting HUD's enforcement efforts, enhancing awareness of fair housing rights, and emphasizing the importance of ending housing discrimination. According to the press release, this year's theme, *Fair Housing: More than Just Words* reflects the Biden-Harris Administration's commitment to advancing equity in housing and the importance of increasing public awareness of everyone's right to fair housing.

Secretary Martha L. Fudge and guests will be holding a virtual celebration on April 7, 2021, at 2 p.m. Eastern time that will focus on the current administration's pledge to "end housing discrimination, provide redress for those who have experienced housing discrimination, eliminate racial bias in all stages of home buying and renting, and secure equal access to housing and opportunity for all."
