PIH Posts Explanation of July Obligations

HUD's Office of Public and Indian Housing (PIH) has [posted](#) a [document](#) explaining public housing operating fund obligations for July 2021. According to the document, July obligations are based on the interim eligibility determined after processing the 2021 operating subsidy forms. The July interim eligibility used for this funding will not include eligibility changes made as part of the recently concluded quality control process. Those changes will be reflected in the August funding. All operating subsidy obligations are cumulative, meaning that public housing projects are provided funding in the amount of seven twelfths of prorated eligibility.

For the July funding, the Department considered 2021 interim eligibility to provide an interim proration level of approximately 96.13%. The final proration will reflect the difference in the amount of the actual eligibility for final approved PHA subsidy requests and the Appropriation Act. HUD plans to make this round of funding available through eLOCCS no later than July 1, 2021. The next round of funding is expected to be available in eLOCCS no later than August 1, 2021.

HUD Announces New Emergency Housing Vouchers Webinar Series

The Department of Housing and Urban Development (HUD) has [announced](#) that it will be hosting a new Emergency Housing Vouchers (EHVs) webinar series. The purpose of this webinar series is to introduce PHAs, CoCs, and other housing stakeholders to opportunities through the U.S. Department of Health and Human Services (HHS) to fund and provide housing-related supports and services that can be coordinated with HUD housing assistance for people who are experiencing or at risk of experiencing homelessness, including the 70,000 EHV's awarded by HUD to PHAs through the American Rescue Plan.

HUD Posts Materials for the HCV Mobility Demonstration Kick-Off Meeting

HUD has recently added the [recording](#) and [presentation materials](#) for the [Housing Choice Voucher \(HCV\) Mobility Demonstration](#) kick-off meeting. The session, held on May 24, 2021, discussed the HCV Mobility Demonstration goals, timeline, and project roles. It also included an overview of the technical assistance and research evaluation.

In April 2021, HUD [announced](#) that nine lead PHAs will participate in its new Housing Choice Voucher (HCV) Mobility Demonstration. Through the demonstration, PHAs will provide over 10,000 families with children better access to low-poverty neighborhoods with high-performing schools and other strong community resources. The demonstration will face a rigorous, independent evaluation to determine what services are most effective at helping families move to opportunity areas.
