### 1. Milestones from the past year

In 2021, the Solar Impulse Foundation's biggest achievement was to reach the mark of 1000 Labelled Solutions in April.

In parallel with the labeling process, the Foundation doubled down on its commitment to work with public and private stakeholders on the implementation of clean technologies. We welcomed new partners, such as Adeo and Holcim, with which we launched "Innovation Challenges" to create business opportunities for Labeled Solutions; we have also established collaborations with new governments and actively participated in the COP26; we revealed two investment funds in partnership with BNP Paribas, Rothschild & Co and Air Liquide; and we organized e-pitches to help our solutions raise money...

Overall, it has been a busy year for the Foundation. And 2022 will be no different!

# 3. Minutes of the 2021 General Assembly of the World Alliance for Efficient Solutions

#### 3.1 Preamble

For the fourth year, the General Assembly was conducted through circulation.

It was addressed to all Founding and voting members of the World Alliance and was intended to update them on:

- The current status of the World Alliance for Efficient Solutions
- The milestones achieved over the past year
- To receive from founding and voting members the approval of new members joining the World Alliance for Efficient Solutions (members up to November 1<sup>st</sup> 2020)
- To receive from founding members the approval of the minutes of the 2020 General Assembly

#### Timeline:

The first email was sent on the  $27^{th}$  of January 2022. The deadline for the Founding and voting members to give their approval was fixed on the  $10^{th}$  of February 2022, with a reminder sent on the  $1^{st}$  of February 2021.



### 3.2 Endorsement of the minutes of the 2020 General Assembly

#### **Results of the votes:**

By simple majority, the World Alliance for Efficient Solutions has approved, on the  $10^{th}$  of February 2022. the minutes of the 2020 General Assembly, which was held last year on the  $16^{th}$  of December 2019.

# 3.3 Approval of new members of the World Alliance for Efficient Solutions

Founding and voting members of the World Alliance for Efficient Solutions were also invited to approve the membership of **new members that have joined since the last General Assembly.** For this year's, founding and voting members had to approve the list of companies **that have joined from the 1**<sup>st</sup> of **November 2020 until the 1**<sup>st</sup> of **January 2022, which contained 822 companies**.

The membership to the World Alliance remained provisional until approved by Founding and voting members.

As a Founding member or voting member, they had the right to either:

- 1. Approve all new members
- 2. Refuse the approval of one or more new members by providing the name of the company followed by the reason why they did not want to validate the membership

*Note: Non-response to the email was taken as an approval of all new members.* 

#### **Results of the vote:**

All Founding Members and all new members approved since the last General Assembly, were noticed on the 27<sup>th</sup> of January 2021 by email and had 2 weeks to approve or not the membership of the new members.

We received a total of 22 answers, all of which were in favour of the approval of the list of new members of the World Alliance for Efficient Solutions.



1 Voting Member expressed doubts on 1 company concerning its credibility. Against a simple majority of the votes to approve, such objection was not sufficient to refuse the membership of the innovator in question.

2'838 did not respond to the email, therefore it was taken as an approval of all members from their part.

822 new members were officially approved by simple majority as members of the World Alliance for Efficient Solutions. Taking into account the recently officially approved members, Founding Members and the Foundation Partners, the total number of members of the World Alliance for Efficient Solutions on the 1st of January, 2022 is 3'660 members.
