

#### SECTION 5.0

## **About CIOP Examination**

Inventory Optimization Certified Professional (CIOP) examination is based on Inventory Management Body of Knowledge v3.0. CIOP examination a 3-hours, online, closed-book examination delivered Fhyzics' Learning Management and Assessment System (LMAS). The examination contains 120 Multiple Questions (MCQs). Each Choice question has 4 options and the participants are advised to choose the





most appropriate one. There is only one correct answer to the question. All are case study / scenario based questions and there are no negative marks. Each question carries 3 marks and the total mark is 360. Candidates need to answer at least 70% of the questions correct (84 questions = 252 marks) to secure a pass in the examination. The result will be released within 7 days of taking the examination and the candidates will be notified through their registered email. Successfully passed candidates will receive the CIOP Certificate as soft-copy and hard-copy. CIOP certificate is issued for life and there is no recertification required.


