South Africa joins a growing list of countries around the world who've legalized some form of cannabis production, research, and access. In 2019, the Southern African cannabis market generated an estimated \$1.4 billion in sales and is forecasted to grow at a modest 7% a year to be over \$2 billion by 2024. Business opportunities currently include cultivation and the importation of medical cannabis as well as over-the-counter CBD products. To date, the South African Health Products Regulatory Authority has received 20 applications for medical cannabis cultivation and was recently the first country on the continent to carve out a federally approved market for nonprescription CBD.

Despite the nascency of the country's market opportunities, its potential has attracted a notable amount of foreign investment. Three Canadian companies have established presences there: Canopy Growth has a medical cannabis subsidiary, Spectrum Therapeutics; Aphria has a joint venture with CannInvest Africa, and Alberta-based Aurora Cannabis has a supply agreement with Akula Trading.

"Cannabis is one of mankind's oldest natural resources and is now making its resurgence in Africa's legal markets," said Mike Catalano, Head of Medicinal Genomics' Genomic Services and International Sales. "Medicinal Genomics is proud to partner with Diagnostech to not only deliver



molecular tools that impact cannabis safety and consistency, but also screen for genetic traits that drive sustainable cultivation. Their local knowledge, commitment to quality and pursuit of novel technologies makes them the most forward-thinking company in the African market."

The Covid-19 pandemic notwithstanding, MGC's growth has tracked the acceptance and legalization of cannabis internationally by establishing partnerships with the leading biomedical and life science distributors in Northern Macedonia, Columbia, Argentina, Panama, Israel, Paraguay, Uruguay, Thailand and the Caribbean, and has added distribution agreements with global powerhouses Agilent, Eurofins, Hamilton and MGI.
