### What is GDPR?

The General Data Protection Regulation (GDPR) went into effect May 25, 2018. This new regulation dramatically changed the way data must be handled and processed in the European Union. EU Citizens now have many rights under GDPR, including (but not limited to):

- Use or collection of personal information must be fully consented by the individual, and this must be done with a positive, unambiguous opt-in
- Individuals will be able to request information on the data a company holds on them
- Individuals can request to be forgotten or removed from all systems
- The Individual can object to the use of their data in specific ways
- All data breaches must be announced within 72 hours

### Who Does it Affect?

GDPR does not only affect businesses in the European Union. If you do business with EU businesses', EU residents', or any EU citizens' data, even if you do not have a physical location in the EU, you must comply with the GDPR. The Repercussions of non-compliance will be costly, with fines of up to the greater of €20 Million or 4% of corporate annual revenue for companies that do not comply. Additionally, compliance is not a one-time exercise. There are intricacies involved with becoming compliant and then maintaining compliance.

### How Can the iGrafX GDPR Suite Help?

Effective application of GDPR needs a Process-Centric business model to bring together all 3 key stakeholders: Legal, IT Architecture and Process Owners. Legal needs to understand the risk exposure within the operations of a company. IT needs to identify "subject data," and where it is processed within the businesses operations. Process Owners need to identify the Controllers and Processors of subject data and then implement the necessary controls to stay in compliance.

Without a Process-Centric Business Model at the heart, you might identify all the data but won't have complete control over all potential personal data breaches. This equals risk. Key elements of GDPR include having records of Processing Activities (Article 30) which a Process Repository is designed to achieve. Looking at GDPR from the process perspective also allows for Process-Centric GDPR surveys to identify key risk areas, and then GDPR Process Templates to accelerate documentation. After achieving compliance, the Process-Centric business model will help you remain compliant into the future. All this, and more, is included with the iGrafX GDPR Suite.
