Responsible product design

- Ergonomics We employ the latest research on comfort and usability in our product development, including outside experts in industrial design and engineering. Because comfortable students are more engaged.
- Safety and durability Our furniture is tested to the highest industry standards. It's built to last so you get to use your furniture longer and spend less on replacements. And we all reduce waste from breakage to landfills.
- Certifications Our products meet SCS® Gold Indoor Air Quality standards for low emissions.

- Responsible sourcing

- Locally sourced raw materials reduce transportation impact and carbon footprint
 - Laminate our primary products feature sustainably managed wood fiber and up to 34% SCS-certified recycled content, SCS® Gold and GREENGUARD® certified.
 - Wood raw materials feature eco-certified composite (ECC) grademark certification, compliance with CARB, ATCM and TSCA; certified 90% pre-consumer recycled content (ISO-14021).
 - Metal Primary suppliers are located within 100 miles of the facility.
 - Foam Primary suppliers are located within 100 miles of the facility.
 - Vinyl Primary supplier is ISO 9002 certified, ISO 14001 (2015) certified.
- o Recycle, reuse
 - Onsite recycling of polypropylene and powder paint for reuse in manufacturing
 - Offsite recycling: metal, metals recovery from wastewater, cardboard, used oil and oil-contaminated debris, fluorescent lamps, paints/solvents, empty nickel anode bags/spent lead anodes, eWaste, batteries, office paper, printing ink and toner cartridges

- Supplier Code of Conduct
 - Artcobell does not do business with suppliers or subcontractors that use forced labor or condone slavery or human trafficking in their business. We have a policy prohibiting the use of vendors that violate forced labor or human trafficking or slavery laws and requiring vendors to comply with all local labor and employment laws. Vendors violating the policy are disqualified. Vendors who violate this policy are disqualified from doing business with our company.

 - Artcobell's Pollution Prevention Plan focuses on overall reduction goals to reduce emissions and hazardous waste generation, substitute non-hazardous chemicals for hazardous chemicals where feasible; eliminate use of solvent-based products, and observe best management practices (BMPs) in all workplaces.
 - Source reduction and waste minimization projects include: Rapid Continuous Improvement (RCI) events, regrind glass-filled poly, extend chemical life in Chrome tank bath, reduced water evaporation, reduce powder paint waste to reclaim/reuse, efficient router programs to reduce wood waste, reduce and prevent scrap metal waste, efficient forklift use, 5S inspection/audit and maintenance program.
