RECRUITING APPRENTICES

Hiring an apprentice is a productive and effective way for you to grow talent and develop a motivated, skilled and qualified workforce.

NATIONAL MINIMUM WAGE

Once you've taken on an apprentice do you know how much to pay them? What is the current national minimum wage for apprentices? The wage tends to change each year around April time. Here we outline the latest changes for 2020.

25 and over	21 to 24	18 to 20	Under 18	Apprentice
£8.72	£8.20	£6.45	£4.55	£4.15

• the above comes into effect on 1 April 2020

Currently, the national minimum wage for apprentices is £3.90 per hour but this is increasing to £4.15 per hour in April 2020.

The minimum apprenticeship wage applies to those aged 16-18, and those aged 19 or over who are in the first year of their apprenticeship.

All other apprentices should be paid the national minimum wage for their age, or more.

Apprentices aged 19 or over who have completed at least one year of their apprenticeship are entitled to the national minimum wage.

This also increasing in April 2020, to £6.45 for 18-20 year olds and £8.20 if you're 21 or over.

There is also something called the "national living wage". This is basically a minimum wage for people aged 25 and over. This is increasing from £8.21 an hour to £8.72 an hour.

FOR EXAMPLE...

AN APPRENTICE AGED 22 IN THE FIRST YEAR OF THEIR APPRENTICESHIP IS ENTITLED TO A MINIMUM HOURLY RATE OF £4.15.

EMPLOYER RESPONSIBILITIES

You've invested the time to recruit an apprentice and pay the correct wage. Here we share the Top 3 Responsibilities you need to know as an employer when hiring an apprentice.

1

There must be a genuine job available with a contract of employment long enough for an apprentice to complete their apprenticeship - minimum one year.

Apprentices must have a minimum of 20 days holidays a year

2

You must pay an apprentice's wages for the time they are in work, in off-the-job training and doing further study.

If you have under 50 employees, you are not required to pay National Insurance Contributions for apprentices under the age of 25 on earnings below the higher tax rate of £827 a week (£43,000 a year).

3

You must ensure you support your apprentice to spend at least 20% of their time on off-the-job training relevant to their apprenticeship.

This could be through webinars, business projects that contribute to their apprenticeship, written assignments or attending training.

You must treat your apprentice as a member of staff, subject to the same rights and opportunities as the rest of you team, demonstrating good health & safety and equality & diversity
