





- I was able to do it yesterday, but it's not working today






Understanding JDE Security Hierarchy

Role Conflict Costs

- With a modest user count of 150, and logging in and out only Twice to resolve security conflicts, the cost is \$38,942
- If users have to log out and in 3 times over the course of the day, the annual cost rises to \$58,413!




