FINANCE REGISTRATION REQUIREMENTS

Domestic Students

The deposit and first payment must be paid by September 1, 2021, in order to register for First or Second Year. This includes Green Card holder students.

International Students

Tuition must be paid in full by the international tuition deadline (see below) in order to register for First, Second, or Third Year. For all international registration requirements, please read the [Visa Packet](#).

Third Year Students

All Third Year students, both domestic and international, must be paid in full to register.

FINANCE INFORMATION

Application Fee

As part of the application process, you will be required to pay a small application fee, which covers the costs associated with processing your application.

Deposit

Your deposit is due within 30 days of your acceptance email, or immediately if you are accepted after August 1, 2021. Your deposit counts towards your tuition costs for the year and secures your place in school.

Scholarships

BSSM does not currently offer any scholarships for students. We hope and pray that in the near future we will be able to set up a scholarship fund that students can apply for.

Donations

After being accepted into BSSM, students have access to a personalized donations page from which donors can make payments directly into tuition accounts. [Click here](#) to donate to students.

International Fees

Tuition fees for international students must be paid in full by the international payment deadline date (see above), as we are unable to offer any installment plans for internationals.

Non-registration may result in your M-1 Visa status being withdrawn, which will require you to return to your home country. [Click here](#) for M1 Visa Info.

Domestic Fees

To be able to register, domestic students must have paid at least their deposit and the first payment. An installment plan is only available to domestic students and consists of three equal payments after the first payment has been paid.

Installment Plans

Installment plans are only offered to First and Second Year students (domestic students only) at registration who have paid at least their deposit and their first payment.

Mission Trip Requirements

Each student is required to participate in a mission trip as part of the school year. Trip costs range from \$100 - \$4,000. Applications for mission trips open in late September.

FINANCE POLICIES

Withdrawal Policy

If a student withdraws, he or she is responsible for any tuition amount still owed to BSSM, minus any applicable refund. In the event that a student withdraws from school and has paid their tuition in full, they may qualify for a refund. See our Refund Policy below.

Refund Policy

Students who withdraw from school before February 1, 2022, and have paid their tuition in full may potentially qualify for a prorated refund. Students who are dismissed from school do not qualify for a refund. After February 1, 2022, tuition is non-refundable. Please email the Finance Team at contact@bssm.net for details.

DISCOUNTS

Early Pay Discount: \$250

Upon payment of the deposit, the early pay discount is automatically applied to each account. The discount is automatically removed if tuition is not paid in full by the Early Pay Discount deadline stated above. You can view your discount on the Payments Page on [MyBSSM](#).

Please note the following for the Early Pay Discount:

- The Early Pay Discount is available for First and Second Year only.
- To qualify, you must have paid your tuition in full by the Early Pay Discount deadline: September 1, 2021.
- Checks or cash payments must be received *before* the Early Pay Discount deadline.

Example Tuition Discounts

We've created different example scenarios to work out what your tuition costs would be with different discount scenarios.

- Two family members (spouse, sibling, parent, grandparent) are both attending First or Second Year: Once both deposits are paid, one student pays full tuition and the other receives a \$1000 discount.
- Three family members are all attending First or Second Year: Once all deposits are paid, one student pays full tuition, both remaining students receive a \$1000 discount.
- One family member is attending Third Year and one is attending First or Second Year: Once both deposits are paid, the Third Year student pays full tuition and the First or Second Year student receives a \$1000 discount.
- One family member is attending Third year and two other family members are attending First or Second Year: Once all deposits are paid, the Third Year student pays full tuition and both remaining students receive a \$1000 discount.

Important Notes:

- Discounts are only applied when all family members have paid their deposit and a family member emails the BSSM Finance Team from their MyBSSM profile, listing the family member(s) and account ID#(s).
- No discounts are given to Third Year students, regardless if multiple family members are attending school.
- If a family member does not register or withdraws from school, any discounts based on that family member will be removed and the discounted amount will become due and payable.

Family Discount: \$1,000

The Family Discount applies to immediate family members attending BSSM in the same school year. For example: a spouse, father, mother, child, brother, sister, or grandparent. For examples of how the Family Discount works, please see below.

Please note the following for the Family Discount:

- The Family Discount is not automatically applied. To apply for the Family Discount, email contact@bssm.net with the names, student ID numbers, and relationship of all eligible family members.
- All deposits of the immediate family must be paid prior to discount being applied.
- The Family Discount does not apply to Third Year tuition. However, any immediate family member who is in First Year or Second Year is eligible for the discount.
- As an engaged couple, you will qualify for the Family Discount if you get married prior to registration.

1) Credit Card
