

### **HOW TO AVOID U-TURNS**

Run-under crashes are one of the most devastating losses a trucking company can experience. A run-under crash can cost thousands of dollars in physical damage and personal injury. However, these crashes are frequently among the easiest to prevent.

Many run-under crashes involve U-turns. A run-under crash caused by a U-turn is possibly the easiest to prevent...never make a U-turn.

#### **RECOGNIZE THE HAZARDS:**

Professional drivers state that making a U-turn is not an acceptable driving technique. When a driver attempts to make a U-turn, the life of the driver and the lives of others may be put in danger. It is important to discuss with your drivers the dangers of making U-turns.

## TWO METHODS DRIVERS CAN USE TO GET BACK ON COURSE WITHOUT MAKING U-TURNS:

In urban areas, find a safe area to turn around. Find an area where a driver can safely turn around without endangering anyone. An open parking lot may work well.

On the highway, circle back through other roads. Roads are interconnected. If a driver happens to miss a turn, chances are a turn or off-ramp exists a few miles ahead. Use them to get safely back on track.

#### **EXCERCISING PROPER DRIVING TECHNIQUES:**

- Never make a U-turn
- Always plan your route well in advance
- Properly monitor the speed of approaching vehicles
- Be aware of what other vehicles are doing
- Install and ensure reflective tape is in good condition
- Avoid backing out onto a roadway
- Make frequent, quick glances to mirrors and windows to monitor the blind spots around the truck.
