Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2019/20 baseline. These measures will be in effect during the course of the contract.

- Flexible Working Policy
- Reduction of onsite datacentre equipment
- Limitation on long haul travel

These have had a positive impact in 2020/21 but it should be noted that Coronavirus lockdowns reduced our overall gas and electricity usage.

In the future we hope to implement further measures such as:

- Reduce our gas usage
- Switch gas and electricity supply to a renewable led supplier/plan
- Promotion of electric vehicle usage with charge points at office
- Promotion of staff public transport use
