Safe water systems and Legionella control

The water network in a building is one of its most important components. Commercial building managers and duty holders are required to comply with the Health and Safety at Work Act 1974, ACOP L8 and HSG274 Part 2: The control of Legionella bacteria in hot and cold water systems in order to protect against risk to human health.

The Health and Safety at Work Act 1974 requires all building owners and operators to assess the risk of Legionnaires' Disease within their property(s) if a risk is identified, ACoP L8 tells you how to manage assets and systems associated with hot and cold water in buildings, temperature, water hygiene (storage and point of use) and control Legionella.

All of these things can be done by a competent person, with appropriate training. If a risk assessment for your property has not been completed, we would strongly recommend one is completed as soon as possible.

If your assessment was completed some time ago and the system or circumstances have changed, it is time to have your document reviewed.

What is covered in a Legionella Risk Assessment?

A good formal (independent) assessment covers all water-related on-site assets, water storage system condition, system hygiene, system integrity, temperature checks, Legionella control measures, a photographic register of assets, a schematic to show the inter-relationship of equipment and risk, recommended actions, ACoP L8 risk management and how to fully comply and remain safe.

When you need a Water Hygiene Risk Assessment

· Where a duty of care exists

Good water hygiene requires:

- Risk assessment to evaluate whether suitable control measures are in place
- · Regular review of the assessment to make sure it is up to date

The Risk Assessment may recommend

- Microbiological analysis of water and UKAS-approved water testing to monitor whether harmful organisms are present
- Water management, water system cleaning and chlorination and control of Legionella and microbiology in pipes and the water distribution system
- A thorough Risk Assessment or Review as a 'base' and regular updates whenever there is a change
- On-going water system monitoring, asset management, hygiene, temperature control, Legionella risk management and protection from waterborne risks to human health.


