

# Why is it so important to get licensing right?

It has never been more important to ensure you are fully receiving maximum value from your IT investments. The global health crisis and subsequent economic downturn is driving organisations to rein in their spending while optimising their operations. However, they can't afford to cut back on key investments in technology, with many digital transformation projects now running at full at speed.

The good news is that optimising your software estate can be an effective way to reduce costs. According to the IT Asset Management (ITAM) Forum, organisations that can optimise spend on their IT environment can save at least five percent on their IT and software costs every year, with most being able to save much more than that.<sup>1</sup>

The reason for this is that many organisations don't currently fully optimise their software licences. With unsanctioned spending on technology by individual departments and employees on the rise, organisations often don't know what assets they have or need. Indeed, large companies (2,000 or more employees) deploy 163 apps on average, an increase of 68 percent over the last four years.<sup>2</sup>

This means not only are these organisations adding to the complexity of their IT estate – **43 percent of IT professionals cite application sprawl as a top three barrier to realising the benefits of the cloud**<sup>3</sup> – but this is coming at an unnecessary cost. In addition, the software may not be compliant with the company's security and compliance policies, increasing risk to the organisation.
