



Nutritional Analysis Lab Test Instructions

Thank you for choosing RL Food Testing Laboratory for your Nutritional Analysis Lab Test needs. We appreciate your business.

Please complete the attached Nutritional Analysis Lab Test form required to submit with each food sample(s) you are requesting for testing. Contact us if you do not have a form. A completed form is required to accompany each sample product.

Why do you need this test? Often, how foods are processed require lab testing. A few examples are: brined, marinated, deep fried, fermented, filtered, contains alcohol or CBD oil – these product types require lab testing. If your recipe cannot be analyzed through our database software, then your food product requires a sample tested for the Nutritional content - our lab test provides this analysis.

Instructions:

- Complete the Nutrition Analysis Submission form (one per product)
- Submit a 4 oz. sample of the finished product
- Ship overnight or 2nd Day Air
- Use cold packs as necessary
- Do not use glass containers – **SEALED** plastic containers only
- The Lab is closed on weekends – please no Saturday or Sunday deliveries

Testing turnaround time is 20-25 business days. Once samples are submitted, testing cannot be modified or canceled.

The report you will receive at the conclusion of your product testing will indicate the nutrient values required by the FDA for Nutrition Facts Labels. These include: Calcium, Calories from Fat, Total Calories, Total Carbohydrates, Cholesterol, Trans-fat, Saturated Fat, Total Fat, Dietary Fiber, Iron, Protein, Sodium, Sugars, Vitamin D, Potassium. (Ash and Moisture results are also included.) We use the information from this report to produce your FDA compliant Nutrition Facts Label – which is included as part of RL Food Testing services.
