**Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

The Allotment Committee of the Board of Directors of the Company at its meeting held today, has approved an allotment of 36,337 equity shares of Rs.10/- each, being the exercise of 10,312 equity stock options under the Employee Stock Option Scheme, 2009 - Plan B (ESOS 2009 – Plan B), 25,312 equity stock options under the Employee Stock Option Scheme, 2013 (ESOS 2013) and 713 equity stock options under the Employee Stock Option Scheme, 2014 (ESOS 2014). The allotment includes allotment of 8,438 equity shares under ESOS 2009 – Plan B and 25,312 equity shares under ESOS 2013, aggregating to 33,750 equity shares to Shri A V Dharmakrishnan, Non-Executive Director. Consequent to this the paid up equity share capital has increased from 3,04,83,497 equity shares of Rs. 10/- each to 3,05,19,834 equity shares of Rs. 10/- each. The meeting commenced at 5.30 p.m. and concluded at 6.00 p.m.

The Company shall apply for the listing and trading permission shortly.
