# The Critical Role of Paralegals in Entity Management

It is widely recognized that paralegals function as the backbone to law firms and in-house legal teams. While lawyers spend their time structuring new deals or working with clients, paralegals perform the substantive and procedural legal work as well as routine administrative tasks.

#### **Paralegals Within a Firm**

In addition to entity management, corporate law firm paralegals often fulfill fundamental duties such as preparing legal documents, legal research, and filings. Paralegals working for law firms are often delegated a large scope of transactional work. They fulfill project management roles and have direct contact with clients while maintaining clients' corporate records.

#### **In-House Paralegals**

Compared to a law firm setting, working in a legal department presents paralegals with other challenges. On one hand, in-house paralegals have a more structured work schedule compared to working in a law firm. They are also less involved in transactional work as these duties are most often handled by partner law firms.

On the other hand, in-house legal professionals are frequently engaged in interdepartmental work. In this role, paralegals focus on project management, corporate record maintenance, and liaison with the external legal counsel while sharing responsibility for delivering the whole suite of entity management services. Meanwhile, it is also not uncommon for in-house paralegals to fulfill administrative duties while having to oversee the legal workflow for the entire organization.

# Why Job Turnover Among Paralegals is the Highest

While paralegals are central to the workflow of law firms and in-house legal counsel, many of them burnout quickly due to being understaffed and underappreciated, lacking the tools and support from the organization. This, in turn, has negative consequences both for paralegals and for the rest of their legal teams.

Under current conditions, corporate paralegals are often overstressed and overworked, which leads to human error, detachment and loss of motivation and leads to job churn. For law firms and legal departments, the high turnover of integral personnel:

- Poses higher costs due to the constant need for new hire and training.
- Risks important processes being disrupted and disorganized.



Although some may argue that technology alone may not be enough to change the modus operandi in the industry, it can still make the workflow of paralegals so much easier, saving precious time and mental effort that can be utilized to cope with the ever-increasing workload. Such tailored technology solutions should effectively address paralegal pain points and make their work less time-consuming, more efficient and, as a result, more rewarding.

For corporate paralegals, these pain points include the most common issues related to entity management and governance. These issues can be broken into several groups, such as physical minute book issues, technology issues and collaboration.

## **Physical Minute Book Issues**

While some law firms and in-house legal teams maintain an electronic copy of their clients' corporate records, many of them still have the minute book in physical form. Keeping a minute book in paper format requires mailing out documents for physical signature and scanning them for electronic copies. This way of keeping corporate information has several major drawbacks, placing an unnecessary toll on the whole organization in general and paralegals in particular.

First of all, keeping a minute book in paper format promotes the risk of losing documentation. With this decentralized chain-of-custody, documents are misplaced or mismanaged.

Secondly, scanning documents from a physical minute book takes a lot of time. Meanwhile. sending those files by email poses security risks and is not always feasible, taking into account a large volume of scanned documents.

Finally, both the paper and scanned version of the minute book can be outdated when the newly signed documents are sitting on someone's desk and not added to the minute book.

# **Technology Issues**

Working in law firms and in-house, corporate paralegals are often stuck by ineffective and outdated databases, software and systems, which take unnecessary time and do not help them address work overload.

The situation gets even worse if the law firm or legal department heavily relies on spreadsheets to store its corporate records. There has been a lot said and written about why law firms need to stop using spreadsheets as a database to store corporate records and move to more efficient systems. Still, many law firms and legal departments still use spreadsheets for legal entity management, which doesn't make paralegals' lives any easier.

Such heavy reliance on spreadsheets for entity management leads to spending extra time correcting, modifying and updating information in spreadsheets, aligning various spreadsheet databases and sorting out inconsistencies. In addition, spreadsheets pose reputational risks due to human error and can create security issues.

Additionally, paralegals often have to deal with inefficient or inadequate IT support from providers or internal support teams. In many cases, both external and internal IT teams may need considerable time to complete a support request. Meanwhile, busy legal professionals cannot wait days nor hours with the software they are using while handling multiple requests from lawyers and clients.

## Collaboration

With the rise of remote and hybrid work after the outbreak of COVID-19, corporate paralegals more than ever require tools and solutions that ensure collaboration with lawyers, clients, and other teams across the whole organization. 




