**RE: COVID-19 Pfizer Vaccination Administration Schedule / COVID-19 Update #50**

***This memo is applicable for all residents who formally registered for the COVID-19 vaccine on Tuesday, January 12, 2021.***

On Tuesday, January 19, 2021, you will receive the first of two injections of the COVID-19 vaccine, administered by CVS Pharmacy. ***The vaccine clinic will be held in the Auditorium.***

*Please review the schedule on the reverse for your designated time slot. Due to the number of people that signed up for the vaccine, we will be unable to adjust the schedule. Please arrive on time and not early as we will be unable to accommodate those who arrive before their designated time slot.*

**Important details:**

- ✓ Please arrive at your designated time (schedule on reverse).
- ✓ Please bring your Identification and your Medicare Card.
- ✓ **Please wear a short-sleeved shirt to make the injection site visible** (please bring a cardigan sweater if needed for comfort).
- ✓ Make sure you are wearing a mask and adhere to social distancing.
- ✓ You will be asked the following 5 questions. **BE PREPARED TO PROVIDE ANSWERS:**

1. *Are you feeling sick today?*
2. *Have you ever had a severe allergic reaction (e.g., anaphylaxis) in the past? Example: a reaction for which you were treated with epinephrine or EpiPen, or for which you had to go to the hospital?*  
*Was the severe allergic reaction after receiving another vaccine or injectable medication:*
3. *Have you received any vaccines in the past 14 days?*
4. *Have you received monoclonal antibodies or convalescent plasma as part of a COVID-19 treatment in the past 90 days?*
5. *Do you have bleeding disorder or are you taking a blood thinner?*

Bring a list of answers with you if it helps you to remember particularly blood thinners. We will be moving quickly to get everyone completed in an efficient and timely manner.

***IMPORTANT NOTE: After you receive your vaccine, you MUST wait at least 15 minutes, under the observation of a nurse before you are permitted to exit.***

**OVER FOR SCHEDULE TO ARRIVE IN THE AUDITORIUM**



*This 'observation holding area' will be in the 3<sup>rd</sup> floor Parlor. You will proceed there immediately after your vaccination.*

The best and most efficient way to accomplish this is to schedule each floor for specific time frames. The schedule will be as follows:
