The Challenge

With the pressures of GDPR compliance, NATS needed to be able to anonymize sensitive corporate data stored within the SAP enterprise platform. Being unable to do it easily meant that NATS teams were having to do full security assessments, applying the same level of security to the non-productive SAP environments as they did to the live systems. This was time consuming, slowing down critical projects and hindering progress. On top of this, they were not getting the full value from their non-productive environments. Creating test data via the SAP system copy process was costing them considerable time and effort. Furthermore, running their SAP systems on a HANA database meant that as their database grew, so too did their hosting costs. They needed to rein in the size of their non-productive environment and save substantial infrastructure costs fast.

The Solution

NATS researched options to address the data sensitivity, provision and cost challenges and chose SNP's CrystalBridge Test Data Organizer (TDO). TDO was deployed for the two larger SAP landscapes: SAP ECC and SAP BW. One of the first benefits that NATS was able to quickly realize was the anonymization of sensitive and personal data across both systems. This has helped the company meet its requirements regarding the GDPR and has also meant that projects could get underway much quicker because it is possible to make environments available to third parties without exposing sensitive data.

Thanks to TDO, NATS uncovered certain personal data being stored in places where they were not expecting it. This has proved an unexpected benefit, prompting questions regarding the data quality and helping to improve the overall approach to the testing strategy.

NATS previously created test data the standard way via the SAP system copy process. Using TDO, they can now transfer the required master data and transactional data from source to target systems without the usual time, effort and impact on the source system, or on the project itself. The software solution has improved data consistency, enhanced test data quality and significantly reduced runtimes compared with system copies.
