



Share Buyback: Announcement According to Article 5(1)(b) and (3) of Regulation (EU) No. 596/2014

Purchase of Own Shares: 28th Interim Announcement

In the period from March 22, 2021 up to and including March 26, 2021, a total of 1,400 shares were acquired as part of the share buyback program. The commencement of the share buyback was announced on August 13, 2019 in accordance with Article 5 of Regulation (EU) No. 596/2014 and Art. 2(1) of the Delegated Regulation (EU) 2016/1052.

The total number of shares repurchased between March 22, 2021 up to and including March 26, 2021, the volume-weighted average price and the volume in euro are as follows:
