



MAFSI ATTORNEY CONSULTATION BENEFIT

One of our benefits as a MAFSI member is an annual 15 - 20 minute consultation with an attorney known to us as being experienced and knowledgeable about the manufacturers' agency business and laws that govern rep/principal relationships.

The purpose of this short consultation is to enable you to get a quick answer to a general legal question. It is not intended for you to get specific legal advice or services such as a contract review or even a contract clause review.

The attorney with whom you are speaking will make the decision as to whether the consultation falls under the no-charge member benefit category or under a fee for service category. If the attorney believes the service is one for which you should be invoiced, he should notify you and allow you to make the decision as to whether to proceed or not. Part of this notification would include the hourly rate and an estimate of the amount of time involved.

Attached is the list of attorneys known to MAFSI as being experienced and knowledgeable about the manufacturers' agency business and laws that govern rep/principal relationships. We ask that you limit your no-charge call to one attorney only on the list. If you call one of these attorneys and they are in court or for whatever other reason are unable to speak to you in a reasonable period of time, you may then try another on the list.
