

As a GAMS[™] Certified Professional, you are among a distinguished community of gaming industry professional who are dedicated to continuing their education, careers and casino compliance.

How to Become **GAMS**[™] Certified:

- 1. Apply for ICGIP
- 2. Train with the AML Professional Development Program
- 3. Successfully pass the online proctored examination

EXAMINATION OVERVIEW

The GAMS[™] Certification Examination consists of multiple choice questions covering the knowledge areas as defined by the course modules. The candidate will have 3 hours to complete the exam. The examination is computer-based with online proctoring.


EXAMINATION RETAKES

The examination retake fee is \$290 and must be received prior to scheduling the examination.

If a candidate has three failed attempts, the candidate will be required to retake the AML Professional Development program prior to being granted approval to retake the GAMS[™] Certification Examination.

GAMS[™] CERTIFICATION

Candidates who successfully pass the GAMS[™] Examination will receive notification from ICGIP. Within the next 4-6 weeks, you will receive your GAMS[™] Certification Certificate and pin.

REQUIRED DOCUMENTATION

Resumes and copies of professional certifications (if applicable) must be submitted with the completed application.

REFUNDS AND CANCELLATIONS

Program costs are non-refundable upon ICGIP approval into the program. If the candidate cancels prior to program approval, a \$100 application processing fee will be assessed and refund issued.

ACCESS AND COMPLETION

Program participants will have access to the virtual classroom for one year. Upon completion of the program, a Certificate of Completion and 15 Continuing Education Units will be awarded to the program graduate.

Graduates will then qualify to take the GAMS[™] Certification Examination.

WHO MAY APPLY TO TAKE THE GAMS™ EXAMINATION?

Access to take the GAMS[™] Certification Examination is exclusively for ICGIP Professional Development Program registered participants. Applications to take the examination are sent directly to program participants. ICGIP will review the applications and send notification of approval or denial within two weeks.

Taking the GAMS[™] Certification Examination is optional. Candidates may elect to participate in the AML Professional Development Program in preparation to work towards future certification or to obtain Continuing Education Units.

EXAMINATION OVERVIEW

The GAMS[™] Certification Examination consists of multiple choice questions covering the knowledge areas as defined by the course modules. The candidate will have 3.5 hours to complete the examination.

The GAMS[™] Examination is computer-based with online proctoring.

EXAMINATION RETAKES

The examination retake fee is \$290 and must be received prior to scheduling the examination. If a candidate has three failed attempts, the candidate will be required to retake the AML Professional Development program prior to being granted approval to retake the GAMSTM Certification Examination.

CERTIFICATION

Candidates who successfully pass the AML Examination will receive notification from ICGIP, and the GAMSTM Certificate will be mailed within 4-6 weeks.

RECERTIFICATION

To maintain the GAMS[™] designation, recertification is required on an annual basis. Candidates for recertification must maintain ICGIP membership, successfully pass the AML Online Recertification Exam, and are required to earn a minimum of 20 Continuing Education Units within that timeframe. CEU must be in topics related only to AML requirements.
