Property of Altomaxx Technologies

1. PURPOSE

The purpose of this procedure is to establish, implement and maintain the system to ensure that AltoMaxx Technologies has applied controls to the use of certification marks, logos and accreditation symbols.

2. SCOPE

This procedure is applicable to all certification schemes for which AltoMaxx Technologies provides services.

3. TERMS AND DEFINITIONS

Accreditation Symbol

A logo issued by Accreditation body to be used by accredited Certification bodies to indicate their accreditation status.

Certification Logo

A logo issued by Certification body to be used by certified clients to indicate their certification status.

All applicable as defined in clause 3 of manual.

4. PROCEDURE

4.1 DISPLAYING ACCREDITATION SYMBOL

AltoMaxx Technologies permits the certification symbol to be used in a minimum height of 1 inch and width of 1 inch. An Accreditation Symbol shall not be used anywhere other than accredited certificates or on material that does not pertain to the operation of Unmanned Aircraft Systems.

Marks shall be registered in accordance with the relevant ISO Standard. Where a mark is used the certified organization shall include:

- a) the name of the certified company
- b) the certification mark is not disproportionate compared to the accreditation mark,
- c) the label is positioned in a manner which ensures the relationship between the accreditation mark and the certification mark is clear,
- d) the use of the mark is to be such that there is no implication that the goods or services themselves are approved by the accreditation body and that mark pertains to the process.

Clients are prohibited to alter or modify the certification mark. However, it may be resized, provided the proportions of the entire mark are maintained and the mark is clearly distinguishable.

- a) in 100% black
- b) with a printed size of no less than 1 inch by 1 inch
- c) on a background which ensures visual clarity (no more than 10% colour saturation)

AltoMaxx evaluators are responsible for ensuring that certified clients use certificates, certification marks and accreditation body marks in accordance with the rules provided in this document. Evaluators shall report infringements if any arise.

4.2 INTERNAL DOCUMENTATION

AltoMaxx Technologies displays Accreditation Symbols on documents and certificates that pertain to the certification of Unmanned Aerial Systems, Operations. If the reports contain any interpretations or opinions outside the scope of accreditation, it shall be visibly defined that the information is outside the scope of accreditation.

When AltoMaxx Technologies develops reports and other relevant document formats with an AltoMaxx Technologies logo and Accreditation logo; the Accreditation logo shall not be presented in more prominent way than the AltoMaxx Technologies logo.

AltoMaxx Technologies will obtain permission from the client for this subcontracting process. In case of suspension or withdrawal of accreditation scope, AltoMaxx Technologies shall immediately stop displaying accreditation logos in their certificates/ reports.

4.3 USE OF ACCREDITATION SYMBOL ON ADVERTISING MATERIAL/PUBLICITY

AltoMaxx Technologies shall not use an accreditation logo in advertising or publicity material such as business cards, quotations etc.

4.4 USE OF CERTIFICATION LOGO BY CERTIFIED CLIENT

The criteria for use of logo takes into consideration requirements within the ISO Standards. Other governing airspace regulatory bodies may accompany the certification logo to provide additional information ensuring transparency in what is certified. Regulatory mandated identifiers shall be used in place of market area designators when so required. Incorrect use of the logo permits AltoMaxx Technologies to tak

4.5 ACTION AGAINST NON-COMPLIANCE

Where the client or the certification body misuses the mark of conformity the withdrawal of the mark use and/or appropriate legal action where required.
