

## 1. TERMS AND CONDITIONS

- 1.1 Six Degrees Holdings Limited run multiple prize draws at over 100 events across the UK. Previous prizes have included retail vouchers, iPad's, Kindle's, Lego and more. These terms apply to all prize draws taking place in conjunction with events in the UK only.
