## Compensation Provided by Intended Parents

Estimate Only. Compensation may vary depending upon your specific circumstances. The following benefits are paid through the Intended Parents escrow account.

### Surrogate Compensation Package

#### Surrogate Fee

• 1st time California surrogate fee: \$45,000	
• Surrogates carrying twins will receive an additional \$7,500 for the twin pregnancy.	\$45,000
• \$2,500 C-section fee	

#### IVF Transfer Fee

• IVF Transfer \$1,500 per transfer	\$1,500
• Cycle Allowance \$500	\$500

#### Pregnancy Allowance

• 9 months at \$300 for singleton	
• 9 months at \$400 for twins	\$2,700
• Starts on the 1st or 15 the month after confirmation of pregnancy by blood test	

#### Household Allowance

• 9 months at \$200 per month for purchasing pregnancy safe household products and healthy prepared foods	\$1,800

#### Maternity Clothing Allowance

• Paid after first trimester	\$1,000

<b>Surrogate Support Group Meeting Allowance</b>	
<ul style="list-style-type: none"><li>• 2 meetings at \$100 per meeting</li></ul>	\$200
<b>Gift for Surrogate's Children's Education</b>	
<ul style="list-style-type: none"><li>• \$1,000 to be divided up between surrogate's children equally</li></ul>	\$1,000
<b>Vacation/Amusement Park Tickets Gift</b>	
<ul style="list-style-type: none"><li>• \$500 to be spent on a vacation or amusement park trip for Surrogate and her family after the delivery</li></ul>	\$500
<b>After Birth Childcare</b>	
<ul style="list-style-type: none"><li>• \$60/day up to \$300/week</li></ul>	\$600-\$1,000
<b>After Birth Housekeeping</b>	
<ul style="list-style-type: none"><li>• \$100/week</li></ul>	\$200-\$400
<b>Lost Wages -Surrogate</b>	
<ul style="list-style-type: none"><li>• Compensation for lost wages will vary based on actual salaries for the surrogate</li></ul>	\$3,000 - \$8,000
<b>Lost Wages -Spouse</b>	
<ul style="list-style-type: none"><li>• Generally the spouse gets anywhere from 7-10 days of lost wages to take when he wants throughout the entire pregnancy. Spouse's lost wages cap of \$2,500</li></ul>	\$2,500
<b>Total Estimated Value of Compensation Package for a first time surrogate (excluding surrogates lost wages and extra bedrest):</b>	\$57,000 & up

- All medical bills and insurance premiums are paid by the Intended Parents.
- Ofcourse childcare and housekeeping are provided if a surrogate is on bedrest
