Hatch Surrogacy

- Estimate Only. Costs may change depending upon your specific surrogate's circumstances.
- Experienced Surrogates receive approximately an additional \$5,000.00 fee per successful delivery.
- Intended Parents pay an additional \$3,000 for matching with a Surrogate residing in California

Surrogate Fee (\$50,000 for 1st time Surrogate in CA. \$45,000 for out of state Surrogate. This fee may vary)	\$45,000- \$50,000
IVF Transfer Fee Per Cycle (assumes one cycle)	\$1,500
Cycling Allowance (per IVF cycle- assumes 1 cycle)	\$500
Pregnancy Allowance (9 months at \$300 per month)	\$2,700
Household Allowance for pregnancy-safe household products & healthy foods (9 months at \$200 per month)	\$1,800
Maternity Clothing Allowance	\$1,000
Gift for Surrogate's Children's Education (after delivery)	\$1,000
Vacation/Amusement Park Tickets Gift (after delivery)	\$500
Life Insurance	\$600-\$850
Background Checks (*costs may vary case by case*)	\$400

Additional Costs for Surrogacy to be paid directly to the Attorney/Escrow Co./Travel Agent

Travel Agent Fee	\$350-\$500
Hotel (Possible 4 nights @ \$300 per night for post transfer bed rest)	\$1,200
Attorney Fees-Recipient Couple	\$6,000-\$12,000
Attorney Fees-Surrogate (includes contract review and signing of the petition for parentage)	\$1,100-\$1,500
Escrow Account Service Fees	\$1,000-\$1,500
Additional Court Costs	\$2,500
Insurance Agent Support/Maintenance Fees	\$250-\$2,000
Estimated Total	\$12,400-\$21,200

Other Potential Costs for Surrogacy

- Health Insurance costs for maternity and delivery coverage range from approximately \$8,000.00-\$35,000.00
- Insurance for Surrogates can be costly. A private Lloyd's of London policy can cost \$35,000.00 for a singleton. Other options may be available.
- There is a possibility of a lien on some insurance policies for maternity costs. If your surrogate has one of these policies it will be required to place \$20,000 in your Escrow Account to cover this lien which would be an insurance cost.
