This mortgage is exclusive to professionals (full list of professions who qualify is available on request) and offers lower monthly repayments during the term of the mortgage compared to our Standard Variable Rate. It can be used to purchase a property, remortgage from another lender, capital raise or switch product from another SBS mortgage. The maximum Loan to Value (LTV) is the amount of a mortgage expressed as a percentage of the purchase price or valuation, whichever is the lower.

Professional Mortgage

Based on a loan of £260,000 for 25 years, on a discounted variable rate of 3.20% for the term of the mortgage the total amount payable would be £381,248.86 made up of the loan amount plus interest repayable by 1 monthly instalment of £1,283.03 followed by 299 monthly instalments of £1,260.17.

- Valuation fee - £450
