Promote a safety culture

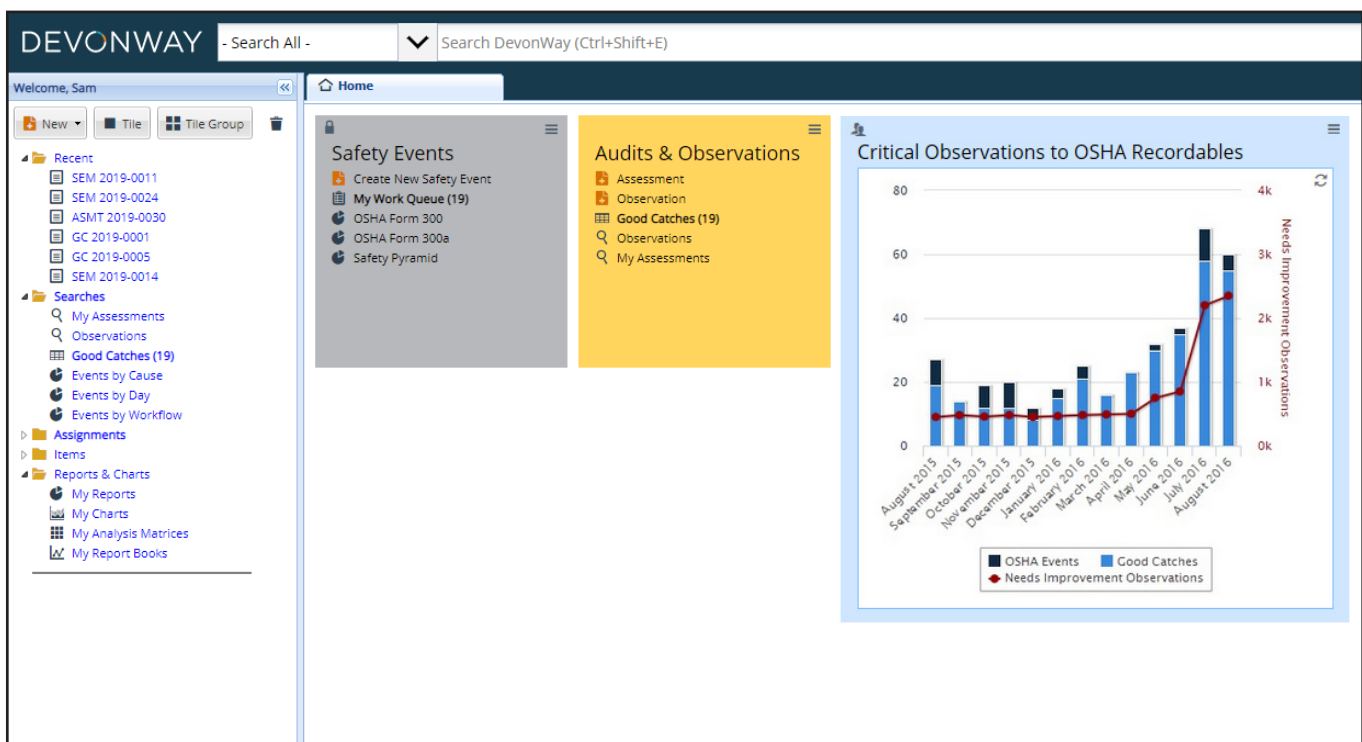
- Manage and report on every incident to avoid future recurrence - from low-threshold items like near misses, close calls, and good catches to key safety incidents like recordable injuries.

Create graded workflows

- Configure workflows with your own business rules to automate as much of the safety event review process as possible.
- Ensure that the most significant events receive the focus they deserve (i.e. events with a higher significance will be subject to more rigorous evaluations, formal action planning, additional approval cycles, or optional effectiveness reviews.)
- Assign actions with associated due dates to the right individuals or teams and route the response to the appropriate levels of approval.

Take action on meaningful data

- Derive safety event insights with in-memory search and ad hoc reporting capabilities.
- Receive email notifications with crucial event information or items coming due.
- Monitor behavior through your observation program or by performing a root cause evaluation through your corrective action program.

✓ Safety pyramid report

The solution generates safety pyramid reports and gives you the ability to filter the criteria on any field.

✓ OSHA reporting

OSHA 300 and 301 reports are automatically generated directly from the system to help maintain compliance.

✓ Optional forms

Have the option to turn on supplemental forms (e.g. bodily injury, claim, etc.) into searchable, reportable online forms.

✓ Configurable workflow

Administer your own workflow settings for incident and event records without having to modify the underlying configuration.

✓ Automatic notifications

Set up your own 'smart' notifications to distribute email alerts and reports on a periodic basis. They may optionally be sent when triggers using defined thresholds are met.
